The Scott County School Board met for the 2017-18 Budget Close Out meeting on Tuesday, June 26, 2018 at 4:00 p.m. at the Scott County School Board Office, with the following members present:

<u>CALL TO ORDER/MOMENT OF SILENCE/PLEDGE OF ALLEGIANCE:</u> Chairman Quillen called the meeting to order at 4:00 p.m. The member and others present observed a moment of silence and Mr. David Templeton led in citing the *Pledge of Allegiance*.

<u>APPROVAL OF AGENDA:</u> On a motion by Mr. David Templeton, seconded by Mr. Larry Horton, all members voting aye, the Board voted to approve the agenda as presented.

ITEMS BY SUPERINTENDENT:

<u>APPROVAL OF NON-TENURED TEACHERS:</u> On a motion by Gail McConnell, seconded by Linda Gillenwater, all members voting aye, the Board approved the non-tenured teacher list for the 2018-19 school year as presented with the changes noted by Superintendent Ferguson. (Appendix A)

<u>DISCUSSION/APPROVAL OF 2017-18 SUPPLEMENT FOR PART-TIME AND FULL-TIME SCOTT</u>

<u>COUNTY EMPLOYEES:</u> Superintendent Ferguson discussed with the Board the figures for the 2017-18 supplement.

On a motion by Mr. David Templeton, seconded by Mr. Gail McConnell, all members voting aye, the Board voted to approve the 2017-18 supplement for Scott County employees as presented for full/part time and cafeteria employees.

APPROVAL OF EXPENDITURES AND CLOSE-OUT OF 2017-18 SCHOOL OPERATING BUDGET:

Superintendent Ferguson presented to the Board the 2017-18 close-out expenditure list with a cash balance as of 6/30/18 of \$979,792.53 with expenditures as of 6/26/18 totaling \$928,624.25 leaving a remaining balance of \$51,168.28. Mr. Ferguson explained to the Board and asked for their permission to expense the remaining budget funds as deemed necessary to balance the fund to zero as state money is received and expenditures are adjusted.

On a motion by Mr. Larry Horton, seconded by Mr. David Templeton, all members voting aye, the Board approved the School operating budget close out amount of \$979, 792. 53 with Superintendent Ferguson having the authorization to make the necessary adjustments as needed to balance the school operating fund to zero as presented.

<u>APPROVAL OF CAFETERIA FUND:</u> Mr. Ferguson presented to the Board the Cash Balance for the Cafeteria fund ending June 30, 2018 as \$170,188.06, expenditures as of June 26, 2018 being \$52,723.46

leaving a balance of \$117,464.60. He explained to the Board that the Cafeteria fund does not have to zero out like the School operating fund.

On a motion by Mr. David Templeton, seconded by Mr. Larry Horton, all members voting aye, the Board approved the 2017-18 Cafeteria fund as presented.

PERSONNEL BY ASSISTANT SUPERINTENDENT, JASON SMITH: EMPLOYMENT:

On a motion by Mr. Larry Horton, seconded by Ms. Linda Gillenwater, all members voting aye, the Board voted to approve Shauna Lawson, teacher, effective for the 2018-19 school year. Ms. Lawson is returning from Leave of Absence.

ADJOURNMENT: There being no Board comments and no further business to discuss, the 2017-18 Budget Close-out meeting of the Scott County School board is adjourned.
