#### MINUTES OF REGULAR MEETING

## **TUESDAY, NOVEMBER 30, 2004**

The Scott County School Board met in regular session on Tuesday, November 30, 2004, in the Scott County Career & Technical Center Auditorium in Gate City, Virginia, with the following members present:

**CALL TO ORDER:** Chairman Sampson called the meeting to order at 6:00 p.m. and presided.

**APPROVAL OF AGENDA:** On a motion by Mr. Campbell, seconded by Mr. Meade, all members voting aye, the board approved the agenda as submitted.

**PUBLIC COMMENTS:** No members of the audience came forth to speak during the Public Comments period.

<u>APPROVAL OF MINUTES</u>: On a motion by Mrs. Blair, seconded by Mr. Kindle, all members voting aye, the board approved the minutes of the Regular Meeting held on Wednesday, November 3, 2004 as submitted.

<u>APPROVAL OF CLAIMS</u>: On a motion by Mr. McMurray, seconded by Mr. Campbell, all members voting aye, the board approved payroll and claims as follows:

APPROVAL OF OVERNIGHT FIELD TRIP REQUEST: On the recommendation of Mr. Darryl E. Johnson, Director of Operations, and on a motion by Mr. McMurray, seconded by Mr. Kindle, all members voting aye, the board approved the overnight field trip request received from Hilton Elementary School sixth grade students to Pigeon Forge and Chattanooga, Tennessee, May 18-21, 2005. Mr. Johnson explained that this date is subject to be changed due to SOL testing and schedule changes.

### **APPROVAL OF AMENDMENT TO THE 2004-05 SCHOOL BUDGET:**

Superintendent Scott presented a revenue and expenditures summary for the School Operating Fund (\$28,293,685); Cafeteria Operating Fund (\$1,299,170) and Construction Fund accounts

(\$293,635). He presented an opportunity for questions and comments on the Amendment to the 2004-05 School Budget.

Superintendent Scott informed board members that the County Board of Supervisors plan to advertise for a public hearing on the Amendment to the 2004-05 School Budget to be held in December and, hopefully the budget would be approved at their January 2005 meeting.

On a motion by Mr. Campbell, seconded by Mr. McMurray, this board hereby approved the Amendment to the 2004-05 School Budget as presented (3,625 Average Daily Membership).

<u>C. DEAN FOSTER, JR. HONORED WITH FINNEGAN AWARD</u>: Chairman Sampson extended congratulations to C. Dean Foster, Jr., County Attorney, for receiving the Finnegan Award and read the following:

?During the LGA?s (Local Government Attorneys) Fall 2004 Conference in Norfolk, C. Dean Foster, Jr., Scott County Attorney, received the 2004 Edward J. Finnegan Award for Distinguished Service. The award is given to recognize a person within or without LGA who has made significant contributions to local government law or to the LGA. Below is a partial reproduction of the LGA resolution detailing Dean?s accomplishments which earned him the coveted Finnegan Award.?

The recipient of LGA?s 2004 Edward J. Finnegan Award for distinguished service has served local government law with professional and personal distinction. His achievements and

longevity in the practice of local government law demonstrate a commitment to the highest professional and ethical standards and have helped enhance the image of local government attorneys in the Commonwealth of Virginia.

Our award recipient currently serves as the Scott County Attorney and has served in that capacity in southwest Virginia for more than twenty-five years. As Scott County Attorney, Dean Foster has performed with grace, agility, and distinction. Over the years, Dean has also consistently distinguished himself statewide as an excellent local government attorney who has developed a profound knowledge and expertise in the area of commercial transactions and economic development.

Our award recipient has been an active member of the LCA almost since its inception. Dean has committed an enormous amount of time, energy, and dedication to the LGA, serving as an LGA board member, treasurer, vice-president, and president. He was among the original directors when the LGA was incorporated in 1987. During his board tenure, Dean implemented the first LGA budget. He has continued to support and work on numerous LGA projects. Dean?s overall dedication and commitment to the LGA has been clearly demonstrated by the fact that over the past twenty-five years, he has rarely missed a semi-annual conference of the LGA.

Most recently, Dean has served as a member of the LGA Committee on Issues Affecting the Development and Interpretation of Local Government Law. In this capacity, Dean has worked first on the Conflict of Interests Act project and then on the Economic Development Incentives project. In conjunction with both projects, Dean voluntarily enlisted the assistance and input from attorneys outside the LGA organization to enhance the information and perspectives presented to the other committee members. Dean?s attendance at the committee meetings held in Richmond over the past two years was exemplary, in spite of the considerable personal sacrifice he endured to travel the great distance from Scott County. Dean?s participation and insightful contributions, his experience, and his colorful metaphors were both entertaining and substantively vital to the final products of these two projects, which have added greatly to the body of local government law in Virginia.?

Members of the audience applauded Mr. C. Dean Foster, Jr., County Attorney, in recognition of his receipt of this distinguished award.

<u>ITEMS BY BOARD MEMBERS</u>: Board members expressed appreciation to the Scott County Career & Technical Center staff for their hospitality. Members also expressed thanks to Ms. Judy Hensley, Culinary Arts Instructor, and students for the delicious meal served prior to the meeting.

Mr. Meade expressed that as his first year on the board comes to a close he has enjoyed working with other members, feels the school system has a lot to be proud of, has a lot of respect for fellow board members, Superintendent Scott, and County Attorney Foster, and is looking forward to working with the Scott County Planning Commission, and hopes that the school system can continue to work well with the Board of Supervisors.
