<u>CALL TO ORDER/MOMENT OF SILENCE/PLEDGE OF ALLEGIANCE</u>: Chairman Jessee called the meeting to order at 6:30 p.m. and welcomed everyone in attendance. He asked the audience to observe a moment of silence and then asked Mr. Spivey to lead the audience in citing the *Pledge of Allegiance*.

<u>ITEMS TO BE ADDED TO AGENDA/APPROVAL OF AGENDA</u>: Chairman Jessee requested an addition to Items By Superintendent (H.) Recognition of State Board of Education. On a motion by Mr. McConnell, seconded by Mr. Spivey, all members voting aye, the Board approved the agenda including the addition presented by Chairman Jessee.

<u>APPROVAL OF MARCH 6, 2012 REGULAR MEETING MINUTES</u>: On a motion by Mr. Sallee, seconded by Mr. Spivey, all members voting aye, the Board approved the Tuesday, March 6, 2012 Regular Meeting Minutes as submitted.

APPROVAL OF CLAIMS: On a motion by Mr. Kegley, seconded by Mr. McConnell, all members voting aye, the Board approved the following payroll and claims: School Operating Fund invoices & payroll in the amount of \$1,039,703.22 as shown by warrants #8102881-8103206 & electronic payroll direct deposit in the amount of \$1,110,484.69 & electronic payroll tax deposit \$469,496.43. Cafeteria Fund invoices & payroll in the amount of \$133,559.33 as shown by warrants #1014762-1014818 & electronic payroll direct deposit in the amount of \$24,022.71 & electronic payroll tax deposit \$10,067.63. Scott County Head Start invoices & payroll in the amount of \$45,968.04 as shown by warrants #10272-10329.

PUBLIC COMMENTS: None.

SCOTT COUNTY IMAGINATION LIBRARY: M.A. Lunsford, Scott County Imagination Library Representative, presented a brief history and success of the Dolly Parton's Imagination Library Program begun in Sevier County in 1995. He presented an overview of the Scott County Imagination Library, which he reported was the first chapter in the state of Virginia that implemented the program. He reported on the program's success in the county and explained that their largest problem is funding. He explained that the objective of the program is teaching a child to read. He presented copies of the program's books for the board's review and explained that each child receives an age appropriate book, from birth to five years. He informed the Board that no funding is received from outside Scott County and explained funding for the program as follows: \$5,000 from the County of Scott Board of Supervisors; \$5,000 from the United Way; \$2,000 from the Rotary Club; and, \$700-800 from the retired teachers association. He stated that he had asked the school board to appropriate funding for the program; and, since he felt it would be inappropriate to ask the Board to vote tonight, he will come back to next month's meeting to ask for a vote on the \$5,000 request for the program. He expressed appreciation to the Board for their time, interest; and, hopefully, support of the program.

Chairman Jessee requested that the clerk include this item on the agenda for the next meeting.

<u>PRESENTATION ON EPILEPSY:</u> Judy Hall, Duffield citizen/grandmother of special needs child in the school system, presented a book on epilepsy to Superintendent Ferguson. She also presented information on Lennox-Gastaut Syndrome and Epilepsy and Seizures and commented on the need for more training and instruction for the faculty and staff in the school system.

<u>VIRGINIA BOARD OF EDUCATION INDEX OF PERFORMANCE EXCELLENCE AWARDS PRESENTED</u>

TO VARIOUS SCHOOLS: Board members presented Virginia Index of Performance Excellence Award Certificates to the principals of Duffield, Fort Blackmore, Rye Cove Intermediate, Shoemaker Elementary, Yuma and Gate City High School; and, to the Weber City Assistant Principal. The awards were presented to the schools from the Virginia Board of Education in recognition for public schools that exceeded the minimum requirements for learning and achievement of the Commonwealth's rigorous Standards of Learning program as follows:

Chairman Jessee expressed congratulations and thanks to the principals and asked that they convey this to the school staff and everyone that shares in the education of the children.

PRESENTATION OF ADVANCED ACCREDITED SACS AWARDS: Scott County Public Schools and each school within the school division received an Advanced Accredited/SACS certificate of accreditation from the Southern Association of Colleges and Schools Council on Accreditation and School Improvement which is valid through June 30, 2017. School board members presented the AdvanceEd SACS Certificates to the principals of each school (Weber City Assistant Principal) for having met the requirements established by the AdvanceD Accreditation Commission and Board of Trustees.

Chairman Jessee stated that he is very proud of the schools, students, teachers, principals, staff and all involved for the phenomenal job that they do.

2012 HEAD START COST OF LIVING ADJUSTMENT (COLA): Helen Henderson, Scott County Public School Head Start Director, reported that Chairman Jessee received a letter from the Department of Health and Human Services stating funding guidance and the application for Cost of Living Adjustment for all Head Start staff. She further explained that this action is from the Consolidated Appropriations Act of 2012. She explained that the amount is \$8,730.00 and is less than one (1) percent increase for all Head Start staff. She reported that the application was presented to the Head Start Policy Council on March 15 and was approved and is being submitted to the school board for approval. She explained that, if approved, the salary scales presented to the Board will be used to reflect changes for the staff. APPROVAL OF REQUEST FOR RELIGIOUS EXEMPTION: Brenda P. Robinette, Supervisor of Special Education, explained guidance provided to the school division in regard to parent requests for religious exemption and then recommended approval of a religious exemption request received (letter dated March 15, 2012) and submitted to the Board. On a motion by Mr. Kegley, seconded by Mr. Spivey, the Board approved the religious exemption request submitted to the Board (letter dated March 15, 2012). Mrs. Robinette informed the Board that she would notify the parents of the Board's action.

APPROVAL OF PALMER CENTER FOUNDATION, INC. GRANT PROJECT: Brenda P. Robinette, Supervisor of Special Education, explained that the school division applied for and was awarded on March 14, 2012, a charitable purpose grant from the Palmer Center Foundation, Inc. She explained that the grant amount awarded is \$29,065.00 and that the funding is to be used for a playground at the Scott County Career & Technical Center for the ABA program. She explained that the request has been made by the Scott County Special Education Advisory Council for the past 5 years but funding was not available. She explained that the agreement presented is requested for when the school division takes over the construction of the project that the Palmer Center Foundation, Inc. not be held liable. On a motion by Mr. Kegley, seconded by Mr. Spivey, all members voting aye, the Board approved the Palmer Center Foundation, Inc. grant project including the agreement as follows:

PALMER CENTER FOUNDATION, INC. HOLD HARMLESS AGREEMENT

The undersigned person or organization warrants that all items of expense funded by the Grant shall be used for activities or projects to individuals and organizations that directly address the mission of the Palmer Center Foundation and that the project shall align with the Palmer Center Foundation's mission statement. The undersigned also warrants that the monies used to fund the Grant shall not be used for political causes, political candidates, lobbying efforts, endowment funds, organizational operating deficits, salaries, stipends, retreats or gifts to individuals or administrators in connection with the project. The undersigned further warrants that the grantee and project are located within Northeast Tennessee and/or Southwest Virginia and that 100% of the services provided through the Grant will be provided to residents of Northeast Tennessee and/or Southwest Virginia.

The undersigned hereby indemnifies and holds harmless the Palmer Center Foundation, its officers, directors, agents, successors and assigns from all claims, demands, damages, causes of actions, judgements, costs and expenses (including court costs and reasonable attorney fees) of whatever nature, direct or indirect, including any events which would give rise to any claim to contribution, indemnity or subrogation arising out of the breach of any warranty contained in this Grant Application or arising out of any claim against the Palmer Center Foundation for death, injury to person or damage to property from the utilization of all monies funded through this Grant. This indemnification shall be binding on the undersigned person or organization, its successors and assigns.

2010-11 CTE ANNUAL PERFORMANCE REPORT: Ralph T. Quesinberry, Supervisor of Career & Technical Education, presented the 2010-2011 Career & Technical Education (CTE) Annual Performance Report (APR). He reported on performance standards as follows: SOL Test – EOC Reading 100 percent (266) of (266) and EOC Mathematics 100 percent (265) of (265). Also, All Special Populations Performance SOL Test as follows: EOC Reading 100 percent (194) of (194) and EOC Mathematics 100 percent (193) of (193). The APR also contains a report of Technical Skills Attainment, All Special Populations Performance, Secondary School Completion, Graduation Rate, Secondary Placement (Transition) Rate, Program Completer Response Rate, Non-Traditional Career Preparation and the Annual Performance Summary. 

PRESENTATION FROM PHILIPS LIGHTING: John Bowman, Southeast Energy Services Manager for Philips Lightolier, presented information on a school initiative program which allows the company to provide 100% financing for projects to upgrade school system lighting. He reported that Scott County Public Schools is one among many having facilities with fixtures that have been banned and will no longer be available after July 14, 2012 and cannot be imported. He informed the Board that changes were mandated by the DOE and EPA. He provided details of a two year project completed this past December for Hawkins County Schools. He informed the Board that he plans to provide a copy of a professional case study to them.

Mr. Bowman explained that the new technology lighting project would reduce the energy, maintenance and operational costs for the school division which would reduce taxpayer supplied funding. He also explained that this savings can then be applied to other areas of need. He further explained that the new lighting can improve the quality of light, reduce glare, reduce eye fatigue, and increase attention span which can increase learning and student test scores.

Mr. Bowman reported that their company has a GSA contract which he explained is that the government has set the price of products and includes labor and distribution guidelines as well. He also pointed out that he understands that this school system has HVAC needs that can be rolled into the lighting upgrade project if requested.

Mr. Bowman informed the Board that if they approve the initiative an auditor from upper East Tennessee will bench mark the existing lighting and design a new replacement system. He stated that he would then present the completed energy proposal to the Board. He further stated that the Board would

approve the cost and payback, sign a contract, and choose how to fund the project whether through Philips Lightolier, grants, or school system funds.

Mr. Sallee asked Mr. Bowman if they assist with grants. Mr. Bowman stated yes.

Mr. Kegley asked about whether Hawkins County received TVA funding for their project. Mr. Bowman stated that they did and explained that a small amount of funding is available to this school division from AEP. Mr. Kegley also asked about their company's plan of removing entire light fixtures and replacing them with new ballast and asked why not let the lights stay in operation; and, when needed, replace the ballast with electronic ballast and then replace with incandescent T8 bulbs. Mr. Bowman commented that you don't get a sustainable lighting system. He explained that if you replace the fixture the benefits are much greater since you get a 15-20 year investment return on your dollar, the benefit of rewiring classrooms to meet current needs and improvement of the quality of education.

Mr. McConnell asked Mr. Bowman out of the total cost of the project what percent does the installation usually run. Mr. Bowman stated that it depends on the requirements and that usually installation is half of the project and more than the lighting itself. He explained that it depends on how invasive the installation. He also explained that typically, to change a fixture out, break it down, recycle the lamp and ballast and discard the housing, it runs about \$45 a fixture. He further explained; however, in areas that were very difficult there was a couple of schools in Hawkins county that fixtures were \$125 each because fixtures were being replaced with fewer fixtures and there was a significant amount of wiring and changing above the ceiling that had to be done. There being no more questions to Mr. Bowman, he thanked the Board for their time and attention.

BUILDING SERVICES UPDATE: Robert Sallee, Building Services Supervisor, presented a Building Services Update containing a few of the items completed during March. He reported that the county placed a recycling dumpster for cardboard at Dungannon Intermediate School. He explained that he is working with an American Electric Power Company representative in regard to the 63 accounts of the school division to merge any accounts that can be in order to save funds. He also reported that he spoke with Jeremy Keller of the Town of Gate City in regard to the water and sewer billings and trash pick up. He explained that the school board is being charged \$1,200 per year for trash pick up for Shoemaker Elementary School, School Board Office, Gate City High School and Scott County Career & Technical Center and the only service provided is cardboard pick up at two of those schools. He reported that the trash pick up is a part of the water and sewer billing whether it is used or not. He explained that at Gate City High School a sewer fee is charged for the watering of the football field and cannot be changed. He reported that he was informed that a dedicated meter could be installed at the football field which would cost approximately \$650 and the fees could be waived. Board members expressed that a meter should be installed and request a written confirmation from the Gate City Town Council that fees would be waived prior to the installation of a meter.

REQUEST FOR EARLY DISMISSAL FOR MAY 23 AT 1:00 P.M.: Superintendent Ferguson requested approval for early dismissal at 1:00 p.m. for the last day of school currently scheduled on May 23, and explained that the request is being made depending on not missing any additional days of school this year. On a motion by Mr. Quillen, seconded by Mr. Kegley, all members voting aye, the Board approved early dismissal at 1:00 p.m. on the last day of school scheduled on May 23 and depending on not missing any more additional days of school this year.

APPROVAL OF APPROPRIATION TO 2011-2012 SCHOOL CAFETERIA FUND BUDGET:

Superintendent Ferguson explained the need for an additional appropriation in the amount of \$372,000.00 to the 2011-2012 School Cafeteria Fund Budget. On a motion by Mr. Spivey, seconded by Mr. McConnell, all members voting aye, the Board approved an additional appropriation to the 2011-2012 School Cafeteria Fund Budget in the amount of \$372,000.00.

SCHOOL BUDGET UPDATE: Superintendent Ferguson reported that the state still does not have final budget figures at this time. He reported that in regard to the fringe benefits (Virginia Retirement System) this is the first time employees hired prior to 2010 will have to contribute since the mid 1980's. He explained that due to the VRS increase it is fearful that localities will have to contribute to offset funds needed. He explained that amendments are expected to be made to the VRS but explained that the increase is expected to take a toll on the school system. He explained that he has been working with various scenarios and will continue to provide information. He reported that he met with the Board of Supervisors Budget Committee and explained to them what is known at this time, the financial situation; and, informed them that it is a question of time in regard to what is the state's final outcome.

Mr. Quillen commented that he thought the public should know that this school division is not the only one in this situation. He explained that things have been outside their powers but that they are proceeding as directed and commented on the need to make the best of resources and the hope that things work out.

APPROVAL OF LINE OF CREDIT FOR 2012-2013 SCHOOL YEAR: Superintendent Ferguson explained the need to request approval from the school board for a \$4,000,000 line of credit for the 2012-2013 school year. He reported that upon their approval he plans to take the request before the Board of Supervisors at their meeting scheduled the following day. On a motion by Mr. Quillen, seconded by Mr. Spivey, all members voting aye, the Board approved a \$4,000,000 line of credit for the 2012-2013 school year and gave Superintendent Ferguson the authority to make the request to the County Board of Supervisors.

<u>EARLY RETIREMENT INCENTIVE PLAN PROPOSAL</u>: Superintendent Ferguson presented a draft Early Retirement Incentive Plan Proposal and recommended Board approval. Will Sturgill, school board attorney, and Superintendent Ferguson answered questions in regard to the draft proposal. On the recommendation of Superintendent Ferguson and a motion by Mr. Quillen, seconded by Mr. Spivey, all members voting aye, the Board approved the Early Retirement Incentive Plan Proposal as follows:

SCOTT COUNTY SCHOOLS ERIP PROPOSAL

ELIGIBILITY:

Participation in the ERIP is subject to the approval of the School board, based on the following factors: Retiree must be eligible to file a Retirement Option with VRS.

Retiree must be currently employed and in good standing with the Scott County School Board; and

Retiree must notify the SUPERINTENDENT OF SCOTT COUNTY SCHOOLS in writing, by June 1, 2012. Retirees under this plan are not required to work any workdays.

INCENTIVE

Employer will pay up to the full cost of Employer's share of the Health Insurance Premium with a maximum payment of Employer being the rate of the current (2011-2012) Health Insurance Premium in the Employer's Health Benefit Plan (if the employer rate increases in the future, only the 2011-2012 rate will be paid by the Employer, if the Employer rate decreases in the future, the Employer will only pay the Employer's share of the Premium). The Retiree shall be responsible for payment of all remaining amounts of insurance premiums. The Premium will be paid until the employee is Medicare eligible (either by disability or age). Upon reaching Medicare eligibility the employee benefit is terminated.

NOTE: ONCE EMPLOYEE BECOMES MEDICARE ELIGIBLE (either by disability or age) PARTICIPATION IN THE GROUP HEALTH AND DENTAL PROGRAM IS TERMINATED.

NOTE: The insurance premium payment will begin as follows:

10 month employee – October 2012

11 month employee – September 2012

12 month employee - August 2012

The Retiree can transfer/enroll to the Employer's health benefits plan, but only during the June 1-15, 2012 enrollment period if he/she is not presently enrolled.
