REPORT OF SCHOOL ACTIVITY FUND AUDIT: Charles Bridwell CPA from Bridwell CPA & Associates, PC presented information on the school activity fund audit. Mr. Bridwell explained that Bridwell CPA & Associates visited every school and conducted each audit on-site. He also stated that over a three year period he has seen significant improvement in internal controls and bank reconciliation and that all schools were in compliance concerning these systems. Mr. Bridwell did express concern over one or two schools carrying over deficit balances from year to year. He explained that the principal or athletic director needs to “0” out these balances at the beginning of each year.

APPROVAL OF FY 2015 HEAD START FIVE YEAR NON-COMPETITIVE GRANT & BASELINE BUDGET: Ms. Kathy Wilcox, Head Start Director, presented the Scott County School Head Start Program FY 2015 Five Year Grant Application and Baseline Budget. On a motion by Mr. Jessee, seconded by Mr. Spivey, all members voting aye, the Board approved the Head Start Five Year Non-Competitive Grant & Baseline Budget as presented.

APPROVAL OF FY 2015 HEAD START FIVE YEAR LONG RANGE GOALS & SHORT TERM OBJECTIVES: Ms. Kathy Wilcox, Head Start Director, presented the Head Start Five Year Long Range Goals and Short Term Objectives. On a motion by Mr. McConnell, seconded by Mr. Sallee, all members voting aye, the Board approved the Head Start Five Year Long Range Goals & Short Term Objectives.

APPROVAL OF FY2015 HEAD START TRAINING & TECHNICAL ASSISTANCE PLAN: Ms. Kathy Wilcox, Head Start Director, presented the Head Start FY 2015 Training and Technical Assistance Plan. On a motion by Mr. Sallee, seconded by Mr. Kegley, all members voting aye, the Board approved the Head Start FY 2015 Training & Technical Assistance Plan as presented.

APPROVAL OF HEAD START COMMUNITY ASSESSMENT: Ms. Kathy Wilcox, Head Start Director, presented the Head Start Community Assessment. Ms. Wilcox explained that the community assessment normally is part of the grant, but that it is different this year. On a motion by Mr. Jessee, seconded by Mr. Kegley, the Board approved the Head Start Community Assessment.

AWARDING OF CREDIT FOR CAREER & TECHNICAL CLASSES: Mr. Ralph Quesinberry, Principal, Scott County Career & Technical Center, presented information on Awarding credit for CTE classes. Presently Scott County Public School students must earn 25 credits for a Standard Diploma and 27 credits for an Advanced Studies Diploma. Mr. Quesinberry explained that some students are completing a sequence of courses in career and technical education and want to return to the career center to take an additional course in that sequence to either take a state licensure exam, as in cosmetology or to prepare for a technical program, as in welding. He also stated that now a student can take a 4th semester in any career and technical program to gain additional skills and knowledge and receive no high school credit. Mr. Quesinberry made a recommendation to allow credit for any career and technical education class beyond the completion of a coherent sequence of state-approved course for the following circumstances: (1) If it is for the purpose of improving their competencies of that trade so that the student can be successful in a state licensure exam and (2) If it is for the purpose of improving the student's competencies of that trade so that the student can successfully transition into a career or college.

On a motion by Mr. Kegley, seconded by Mr. Spivey, all members voting aye, the Board approved awarding credit for career and technical classes.

APPROVAL OF NURSING ADVISORY COMMITTEE: Mr. Ralph Quesinberry, Principal of Scott County Career & Technical Center presented the Nursing Advisory Committee for approval. On a motion my Mr. Jessee, seconded by Mr. Spivey, all members voting aye, the Board approved the Nursing Advisory Committee as presented. (insert)

APPROVAL OF NEW CAREER & TECHNICAL CLASSES: Mr. Ralph Quesinberry, Principal of Scott County Career & Technical Center presented information on two new classes that the Career & Technical Center might be able to implement for the 2015-2016 school year. He explained that these two courses would be: Foundations of Agriculture, Food & Natural Resources and Operating the Farm Business. Mr. Quesinberry explained that teachers would need to be certified in Agriculture and that

Virginia Tech would assist in helping us attain these teachers. Mr. Quesinberry asked for approval to proceed with starting these courses for the 2015-2016 school year.

On a motion by Mr. Jessee, seconded by Mr. McConnell, all members voting aye, the Board approved Mr. Quesinberry to proceed with starting the two new career & technical classes for the 2015-2016 school year.

PUBLIC COMMENT: Ms. Suzanne Goins, Virginia Professional Educators, addressed the board and thanked Mr. Ferguson and Mr. Quillen, Board Members, Mr. Sturgill, and Central Office staff for their hard work and dedication. Ms. Goins stated to the board that VPE offers their services for any teacher in the classroom and that they also offer grants to teachers, teaching assistants, principals and counselors for up to \$500. Ms. Goins also expressed appreciation for the board recognition of retired teachers and other school personnel.

REPORT ON STUDENT ENROLLMENT & PUPIL-TEACHER RATIO: Superintendent Ferguson presented a report on student enrollment and pupil-teacher ratio and explained that the enrollment division wide (with exception of the high schools and middle school) is 2,010 and that the number of teachers is 111 with a ratio of 18.1:1. Superintendent Ferguson also stated that K-3 students division wide equals 1,140 and K-3 teachers equals 66 with a ratio of 17.3:1. DISCUSSION/APPROVAL OF RELIGIOUS EXEMPTION #0220: Superintendent Ferguson recommended approval of Religious Exemption #0220 to be exempt from compulsory school attendance. On a motion by Mr. Jessee, seconded by Mr. Kegley, all members voting aye, the Board approved the Religious Exemption #0220.

BUILDING SERVICES/PERFORMANCE CONTRACT UPDATE: Mr. Robert Sallee, Supervisor of Building Services presented an update on the current maintenance projects for the past month. Mr. Sallee also gave an update on the performance contract and stated controls at Duffield, Nickelsville, Weber City, Twin Springs and Yuma are 100% complete and are now running the schools. He also stated the major mechanical work is 95% complete and the mechanical and control work at the Gate City Middle School and High School is 60-65% complete.

Mr. Robert Sallee explained that controls are operating at set points of 70 degrees for heating and 74 degrees for cooling. Mr. Kegley asked how much of a variance is there on the set points. Mr. Robert Sallee stated that there could be anywhere from a degree to a degree and a half swing. Mr. Kegley stated that we should not see any rooms reaching around 76 degrees and Mr. Robert Sallee stated that if everything is operating correctly, we should not see this and that adjustments will be on going. Mr. Steve Sallee asked if the school system has seen any savings as of yet and Mr. Robert Sallee explained that he has seen some savings in kilowatt usage and btu's and water usage. Mr. Robert Sallee also explained that preventative maintenance will be a major part of the maintenance department's responsibility in the future making sure all equipment is being maintained as it should be.

Chairman Quillen asked for the maintenance department to check the gutter at the Gate City Middle School entrance.
