<u>CALL TO ORDER/MOMENT OF SILENCE/PLEDGE OF ALLEGIANCE:</u> Chairman Templeton called the July 7, 2020 regular meeting of the Scott County School Board to order at 6:30 p.m. and welcomed everyone to the meeting. After asking everyone to observe a moment of silence, Chairman Templeton asked Mr. Robin Hood to lead in citing the *Pledge of Allegiance*.

<u>APPROVAL OF AGENDA:</u> On a motion by Mr. Gail McConnell, seconded by Mr. Robin Hood, all members voting aye, the Board voted to approve the agenda as presented at the meeting.

<u>APPROVAL OF JUNE 2, 2020 REGULAR MEETING MINUTES:</u> On a motion by Mr. Gail McConnell, seconded by Mr. Bill Houseright, all members voting aye, the Board voted to approve the June 2, 2020 regular meeting minutes as written.

APPROVAL OF JUNE 11, 2020 SPECIAL CALLED MEETING MINUTES: On a motion by Mr. Robin Hood, seconded by Mr. Steve Sallee, all members voting aye, the Board voted to approve the June 11, 2020 Special Called Meeting minutes as written.

APPROVAL OF JUNE 24, 2020 BUDGET CLOSE-OUT MEETING MINUTES: On a motion by Mr. Robin Hood, seconded by Mr. Bill Houseright, all members voting aye, the Board voted to approve the June 24, 2020 Budget Close-Out Meeting minutes as written.

**PUBLIC COMMENT:** There were no public comments made at this meeting.

#### **SUPERINTENDENT'S REPORT:**

<u>DISCUSSION/APROVAL OF RESOLUTION FOR PAYMENT OF EARLY INVOICES: (APPENDIX A)</u> Superintendent Ferguson explained to the Board that this annual resolution for early payment of invoices helps to alleviate late charges. Early payment of invoices includes but not limited to utility invoices, registrations, etc....

On a motion by Mr. Steve Sallee, seconded by Mr. Robin Hood, all members voting aye, the Board voted to approve the resolution authorizing the Purchasing Agent to seek the final discretion of Superintendent Ferguson or authorized designee to sign and pay early invoices throughout the month as needed to keep accounts current.

RECOGNITION OF BOARD OF EDUCATION 2020 EXEMPLAR PERFORMANCE SCHOOL AWARDS FOR THE FOLLOWING: (APPENDIX B) Superintendent Ferguson emphasized that while he was very proud of every school in the County that 71 schools in the state of Virginia were recognized with the following awards and he wished to recognize the schools that met the criteria for these awards:

- 2020 BOE HIGHEST ACHIEVEMENT AWARD-GATE CITY HIGH SCHOOL, HILTON ELEMENTARY SCHOOL, AND RYE COVE INTERMEDIATE SCHOOL These schools were recognized for highest achievement and were "Accredited" during the 2019-20 (based on performance data from 2018-2019) and demonstrated high levels of success across all of school quality indicators, including success in narrowing achievement gaps. Schools had to meet the Level One accreditation benchmark for reading, math, and science based on the student pass rate.
  - Superintendent Ferguson emphasized that out of 325 schools that Scott County had two schools to place with the Continuous Improvement Award and he congratulated the staff and administration for this achievement.
- 2. 2020 BOE CONTINUOUS IMPROVEMENT AWARD-RYE COVE HIGH SCHOOL AND SHOEMAKER ELEMENTARY SCHOOL — These schools were recognized for continuous improvement and were rated "Accredited or "Accredited with Conditions" for 2019-2020 and met at least one of the following four criteria based on the performance during 2018-2019:
  - A 10-point increase in the combined rate in reading and math, and in the pass rate in science;
  - A 10-point increase in the combined rate in reading and math for two or more student groups across three years;
  - A decrease in the chronic absenteeism rate for three years; or
  - For schools with a graduating class; an increase in the Graduation and Completion Index and a decrease in the dropout rate for three years.

# DISCUSSION/APPROVAL OF VSBA RESOLUTION CONDEMNING RACISM AND AFFIRMING THE DIVISION'S COMMITMENT TO AN INCLUSIVE SCHOOL ENVIRONMENT FOR ALL: (APPENDIX C)

On a motion by Mr. Gail McConnell, seconded by Mr. Bill Houseright, all members voting aye, the Board voted to approve the extension of the Southern Appalachian Mountain Food Buying Cooperative (SAM Co-Op) from 8/1/20-7/30/21.

# APPROVAL OF BREAD BID (BIMBO BAKERY) CONTRACT EXTENSION 8/1/20-7/31/21: (APPENDIX E):

On a motion by Mr. Steve Sallee, seconded by Mr. Robin Hood, all members voting aye, the Board voted to approve the bread bid extension to Bimbo Bakery from 8/1/20-7/31/21.

### DISCUSSION OF SCHOOL RE-ENTRY FOR THE 2020-2021 SCHOOL YEAR: (APPENDIX F):

Superintendent Ferguson and Assistant Superintendent Jason Smith informed the Board of the different plans of reopening schools and explained how the different options could work. Plan A would be an onsite learning opportunity for all students in which students would attend school Monday, Tuesday, Thursday and Friday from 8:30 a.m. until 2:00 p.m. in the afternoon. Wednesday would be a Remote Learning/Teacher Planning/School Cleaning instructional day and would allow deep cleaning of the schools. The remaining details are outlined in the attached Appendix F. Plan B would be an altered schedule where  $rac{1}{2}$  students would attend onsite Monday/Tuesday and  $rac{1}{2}$  students would be Thursday/Friday. Wednesday would be remote learning-Additional details also in Appendix F. Plan C would offer a Hybrid plan to include: if Virginia is in Phase 3-Prek-7th Grade would follow Plan A; and 8th Grade through 12th Grade would follow Plan B; If Virginia is in Phase 2-Pre-K-3, Special Ed. & EL students would follow Plan A; 4th Grade – 12th Grade would follow Plan D; Plan D: Remote Learning: Remote Learning provides complete remote learning for the Division. If Virginia is in Phase 1, Teachers would use online platforms including Virtual Virginia, Edgenuity, Google Classroom, etc.; Grades would be assigned to assignments; and a Feeding Program implemented. Mr. Jason Smith talked in detail about the Virtual VA learning and explained to the Board members what Edgenuity offered and answered questions from the Board regarding the virtual aspect of this summary. On this Summary there is an Option listed: Selected Virtual which would provide individualized virtual learning for medical fragile students or as requested by parents. This would be a Division led instruction via Virtual Virginia and Edgenuity with Grades assigned to assignments.

Mr. Will Sturgill, School Board Attorney, also spoke to the fact that transportation would be one of the biggest challenges facing the School System as plans are made to start school. Social distancing guidelines would need to be practiced for the best interest of every student. He reiterated that a plan is good to have in place but imperative to have a contingency plan in place and once the School Board's plan is in place and is sent to the VA Dept. of Health and the VA Dept. of Education that we seek those recommendations.

Mr. Smith and Mr. Ferguson emphasized to the Board that each school would need to utilize every available space in the school as a classroom to be able to social distance students properly and keep students safe. They spoke to the fact of masks being worn, face shields when appropriate and recommended and other safety measures, isolation rooms for students who may test positive. Other key points were talked about in regards to the students return to school.

Mr. Will Sturgill spoke to the fact that the School Board can ultimately choose to start with the plan that they feel is the best plan to start with and know that things are subject to transition for whatever is in the best interest of the students.

Mr. Smith did reemphasize that time is of the upmost importance to adopt a plan and that he felt like at some point that Virtual Learning would be a part of anything that they may choose. The Board discussed the different options and the pros and cons regarding each one of the plans and asked

questions of the recommendations the task force. After much discussion, the Board decided they needed more time to make an informed decision on the re-opening of school and to be able to do what they felt best for the students of Scott County.

APPROVAL OF EARLY HEAD START FINANCIAL REPORT, MAY 2020: (APPENDIX G): On a motion by Mr. Steve Sallee, seconded by Mr. Bill Houseright, all members voting aye, the Board voted to approve the May 2020 Early Head Start financial report as presented by Superintendent Ferguson on behalf of Head Start Director Kathy Wilcox.

APPROVAL OF HEAD START FINANCIAL REPORT, MAY 2020: (APPENDIX H): On a motion by Mr. Steve Sallee, seconded by Mr. Robin Hood, all members voting aye, the Board voted to approve the May 2020 Head Start financial report as presented by Superintendent Ferguson on behalf of Head Start Director Kathy Wilcox.

Superintendent Ferguson presented the June 2020 Head Start Director's Report on behalf of Head Start Director Kathy Wilcox for informational purposes. With no comments or questions being raised, the next agenda item was presented.

Summative ratings should apply the rating for each of the seven performance expectations. The Code of Virginia requires that student academic progress be a significant component of the evaluation. How student academic progress is met is the responsibility of local school boards provided that Performance Standard 7: Student Academic Progress is not the least weighted of the performance standards or less than 1 (10 percent); however, it may be weighted equally as one of the multiple lowest weighted standards.

# **Board of Education Announces 2020 Exemplar Performance School Awards**

RICHMOND, Va. — The state Board of Education today recognized 447 schools and six school divisions for high student achievement, continuous improvement or innovative practices under the board's exemplar performance school recognition program. The awards are based on performance and practice during 2018-2019 and prior years.

The recognized schools include 71 schools that earned the Board of Education Highest Achievement Award, 375 schools that earned the Board of Education Continuous Improvement Award and one school that earned the Board of Education Innovative Practice Award. The board also recognized six school divisions for innovative practices. In 2019, the first year of the exemplar performance program, 235 schools earned awards.

"The criteria for the exemplar performance awards are designed to incentivize schools to make the changes in instruction, policy, support services and practice required to make progress toward meeting the Board of Education's objective of achieving equity in opportunities and outcomes for all students," Board of Education President Daniel A. Gecker said. "The increase in the number of awards earned this year is evidence of the progress our schools were making toward this objective before the pandemic forced the closure of schools in March."

"I congratulate the principals, teachers, support professionals and students of all of these schools and divisions for the achievement, innovations and hard work recognized by these awards," Superintendent of Public Instruction James Lane said. "I believe the success of these schools and school divisions will inspire learning communities across the commonwealth as they plan for the reopening of school and prepare to meet the

instructional and social-emotional needs of students — especially students most impacted by the closure this spring."

#### 2020 Board of Education Innovative Practice Award

One school and six school divisions earned the Board of Education Innovative Practice Award. This is the first year the board has issued the award, which recognizes innovations implemented over the course of two academic years that improve student outcomes.

The board recognized Central Academy Middle in Botetourt County for innovative practices to elevate the quality and character of the school environment to create a positive atmosphere for learning and to reflect the norms, goals and values of the community. The six division-level awards for innovative practices are as follows

- Goochland County For division-wide innovative practices to develop life-ready students through implementation of the Profile of a Virginia Graduate and the 5C's (critical thinking, creativity, communication, collaboration and citizenship)
