



## Standards of Learning Pass Rate



#### Recognized by the Virginia School Board Association as a "Showcase Program" for 2010-2011

As part of Response to Intervention, Scott County Public Schools offers a Speech Intervention Program (SIP) in an attempt to give a student the opportunity to correct speech sound errors before a referral to Speech Language Therapy is made.

The Speech Language Pathologist or a paraprofessional works with the student on an individual basis 3-4 times per week for 5 minutes per session targeting speech sounds or language skills. Speech sounds are practiced at different levels of speech (isolation, syllables, words, phrases, sentences, or conversation). A targeted sound or language skill will be considered mastered when the child produces the target correctly with 95-100% accuracy. Sessions involve a goal of 100 productions of the targeted sound. Data is kept to record the student's accuracy. Progress is monitored and reported every nine weeks.

At the end of the nine weeks, data is reviewed and a recommendation is made for one of the following options: a.) Continue the SIP because progress is being noted. b.) Dismiss from the SIP because goals have been successfully achieved. c.) Discontinue from the SIP because progress has not occurred at a reasonable rate and a referral to a more individualized program, such as an IEP, may be needed. The program also serves as a step-down program once the student has been identified as a Speech Language Student and no longer requires direct services. A student may be placed in the SIP to practice their carryover speech/language skills 3-4 times a week for 5 minute intervals. The data is reviewed as stated above and any of the same options may be chosen.




Response to Intervention (RtI) is a comprehensive student-centered assessment and intervention framework used to identify and address individual student difficulties before referral to special education. In using the RtI approach, students receive research-based intervention and assessment. Rather than waiting for a student to fail, interventions and assessments are designed to meet the needs of each student with individualized instruction.

## Rtl's core principles are:

- · effectively teach all children
- intervene early
- · use a multi-tiered model of service delivery
- · monitor student progress to inform instruction
- use assessment for three different purposes: screening, diagnostics, & progress monitoring.



- 21st Century Academy: A competitive federal grant funds two after-school learning programs designed to assist students academically and provide enrichment opportunities. The Shoemaker Little Devil Academy and the Duffield Little Eagle Academy serves a combined average of 170 students daily.

## Applied Behavior Analysis

Scott County Public Schools recognized the need for a systemic change for students ages 3 through 11 with Autism Spectrum Disorders and/or students with significant behavior problems related to skill acquisition. A Board Certified Behavior Analyst (BCBA) is employed to develop a program to better meet the needs of these students. One teacher and an assistant for every three students, providing one-on-one instruction, is crucial to the success of the program. All staff in the classroom are trained to work with each student equally. One of the primary goals is to ensure that the students become comfortable with more than one person. Parent trainings, occupational therapy, physical therapy, and speech services are direct services for the program. The program currently serves 12 students.



## **School Safety**

Through an agreement with the Scott County Sheriff's Office, SCPS has a Resource Officer on the campus of each high school. Their main responsibility is to ensure the safety and well being of students and faculty.

Virginia State Police Officers have partnered with the school system in using an office at the Gate City Complex. When available, state troopers are in the schools working with the School Resource Officers, assisting with the driver's education program, policing the campus, and assisting in crisis planning.

## **Building Improvements**

- Updated security cameras in all schools.
- Installed new controls for the Heating Ventilation and Air Conditioning systems at RCI in the classrooms for more accurate temperature control for the students, faculty and staff.
- Converted Hilton Elementary from an open school house design into individual classrooms.
- Assisted Johnson Controls in the installation of energy management system and HVAC controls for all classrooms on 1st & 2nd floor, and the boiler room at GC Complex. This installation has allowed precise control for all temperatures in the classrooms to provide a more comfortable learning environment for the students.
- Instituting a preventative maintenance program/schedule for all electrical and mechanical equipment in each of the schools.
- Conducted with West Virginia University an OSHA 10 Hour Construction Certification class for all Building Services personnel.

## **Environmental Friendly Initiatives**

- Completed the installation of 10 new Green Energy Star, energy efficient rated HVAC units with the ozone friendly R-410A refrigerant. (8 @ HES and 2 @ TSHS)
- Began Installing new energy efficient T-5 fluorescent lighting fixtures in GCMS, RCH, and TSHS gyms. This installation will help reduce the amount of Greenhouse Gas Emissions and is projected to save approximately \$4600 in the first year.

## ALTERNATIVE EDUCATION


Individual Student Alternative Education Plan Program (I.S.A.E.P.)

is designed to assist students ages 16 to 18 years of age, who are enrolled in high school and are experiencing difficulty finding success in a regular classroom environment. The purpose of the ISAEP program is to provide students with a "second opportunity" to exit high school with a well-recognized credential and the knowledge and skills necessary for a successful transition to adulthood through participation in a career technical program.

The requirements for the program are: Initial Principal-Parent-Student (PPS) meeting,

7.5 grade equivalent or higher on a recognized standardized measure of reading achievement (TABE), an individual student evaluation / assessment, and an achievement of a score of 410 or higher on each subtest of the Official GED Practice Test.

- 11 students served during 2010-2011
- A total of 5 students passed ALL components of the GED (the other 2 who attempted passed all components except for math.)
- Three students carried over to continue during the 2011-2012 school year.
- Number of students served thus far in 2011-2012 school year = 6



- ~ Number of students served during the 2010-2011 school year: 75
- ~ Number of students served during the 2011-2012 school (thus far): 33

## **Renaissance Program**

The Renaissance Program was developed to positively affect the lives of students who are at-risk of dropping out of school because of multiple factors. Many do not succeed in the traditional school setting because the student requires instruction in a different manner; some have failed to comply academically; others may be a parent or expectant parent; some students are employed and the employment is necessary to support his or her family; and some students have behavior problems.

## Scott County Career & Technical Center



During the past year we have expanded and increased both the sections of CTE classes taught and the duplicated number of students taking CTE. Duplicated numbers of students taking CTE reflects students taking more than one CTE class during the year or students taking more than one section of a CTE class during the school year. The school year of 2010-2011, Career and Technical Education had 116 sections of classes for a total duplicated number of 1,792 students. The previous year of 2009-10, Career and Technical Education had 101 sections of classes for a total duplicated number of 1,455 students.

The State of Virginia started requiring students in CTE to take and pass a certification test in a pathway that they were studying during their secondary education. In 2009-10, Scott County School students passed 119 certification test and exams. This past year students passed 144 certification test and exams. This number represents 54% of completers passing a certification.

The Annual Performance Report for CTE from the Virginia Department of Education has shown that CTE students have met and in areas shown improvements in the 11 standards that the state is required to measure as set forth in the No Child Left Behind Act of 2001. At the beginning of this school year we already have 92 students enrolled in dual enrollment classes from Mountain Empire Community College. We have consistently and abundantly won at district, state and national competition in our co-curricular student organizations. We also have been recognized by the Virginia Department of Education for having the most student completers receiving advanced diplomas.

The CTE program is committed to providing the best education possible for each individual student based on their ability. We will continue to evaluate each program to ensure that it meets or exceeds the demands of the local job market.






## TECHNOLOGY IN SCOTT COUNTY

The Scott County Technology Department continuously strives to provide our students with 21st Century learning skills by providing the best solutions possible to meet their technology needs. Over the past year we have.....

- Increased our bandwidth to provide more "online" opportunities.
- Installed 250 new desktops to replace aging existing labs
- Replaced old network at one school to increase throughput from 100MB. Our plans are to finish the final four (out of 14 schools) during the course of this school year.
- Implemented our Student Information System's Parent Portal to allowing parents access to student grades and attendance.
- In process of installing complete wireless connectivity at two remaining high schools
- In process of implementing an instant messaging system to alert parents to emergency situations at school. This system will be an informational tool to keep parents abreast of school happenings such as open house, PTO meetings, etc
- Implemented a Principal iPad Program
- Fully implemented a domain which allows faculty and students to log onto any computer in our network to access their email and documents. This puts the information on the server to prevent loss of data in the event of a computer crashing.
- Implemented Windows 7 operating system district wide.
- Implemented the latest Microsoft Office-2010 onto every computer in the district.
- Implemented a "Work-at-Home" agreement with Microsoft that allows our staff to purchase, at a reduced cost, their own copy of the latest Microsoft Office product.
- Overhauled district website.
- Barracuda backup-catastrophic event backup system.
- Moving to virtualized servers to cut cost. One virtual server is now taking the place of four standalone servers.
- Installed multiple SmartBoards over the year and one Smart Table
- Installed multiple ceiling mounted projectors to allow better viewing capacity for our students.




## Number of Department Employees
